With new VA national, state and tribal cemeteries opening soon, almost all eligible Veterans will have a VA burial option within about an hour's drive from home.



## HOW TO PREPARE YOUR ONLINE ACCOUNTS FOR THE FUTURE



Different platforms have different policies.

*I recently had an estate plan drafted, but I am not sure what to do about my online information such as email, banking and social media accounts. What can I do to ensure my family can access and protect this*

*information after I am gone?*

In addition to creating an estate plan, you should also consider making a “digital will” that lists all your online accounts and login information. This informal document serves as an inventory of your digital assets and provides instructions for accessing them after your passing. A digital will can help your loved ones access your electronic devices and online accounts so they can manage these affairs according to your wishes.

Many nonprofits and businesses offer a no-cost digital-assets inventory worksheet to help you get started. You may also find it helpful to use a password manager or similar tool that allows you to organize your online-account details alphabetically. Here are a few other tips:

**Apple** If you are an iPhone, iPad or Mac user, you should nominate a “legacy contact” who can access your account’s data after you die. This is a secure way to give trusted people access to photos, files and messages. To set it up, you will need an Apple device with a recent operating system (OS) – for example, iPhones and iPads need iOS or iPadOS 15.2, and MacBooks need macOS Monterey 12.1.

For iPhones, go to Settings, click on your name, tap Sign-in & Security and then Legacy Contact. You can select one person to be a legacy contact. The person you select does not need an Apple ID or device. To complete the process, you will be provided with an access key to share with your contact. It can be shared electronically, printed as a copy, or saved as a screenshot or PDF. Once you complete the process for one person, you can go through the steps again to name additional legacy contacts.

Take note that there are some types of files you will not be able to pass on, including digital rights-protected music, movies and passwords stored in Apple’s password manager. Legacy contacts can access a deceased user’s account for three years before Apple deletes the account.

**Google** This platform takes a different approach with its [Inactive Account Manager](#), which allows you to share your data with someone if it notices you have stopped using your account.

When setting it up, you need to decide how long Google should wait – anywhere from three to 18 months – before considering your account “inactive.” After the designated period of inactivity, Google will notify up to 10 people.

You can choose what types of data they can access, including emails, photos, calendar entries and YouTube videos. There is also an option to automatically delete your account after three months of inactivity, so your contacts will have to download any data before that deadline.


**Facebook and Instagram** If you have Facebook or Instagram, both of which are owned by parent company Meta, you can have your accounts either memorialized or deleted after you die if the companies get a valid request from a family member or friend. Go to [facebook.com/help/1111566045566400](https://facebook.com/help/1111566045566400) or [help.instagram.com/264154560391256](https://help.instagram.com/264154560391256) for details.

Meta also strongly recommends that Facebook users add a legacy contact to look after memorial accounts. Information on this process can be found at [facebook.com/help/1070665206293088](https://facebook.com/help/1070665206293088). Legacy contacts can do things like respond to new friend requests and update pinned posts, but they cannot read private messages or remove or alter previous posts. You can only choose one person, who must also have a Facebook account.

**Passwords** If you use a password manager – a service that creates, saves and manages passwords – for all your online accounts, it may have an emergency access feature. Some services will allow users to nominate one or more trusted contacts to access your keys in case of an emergency or death.

## DAV VOLUNTEER DRIVER PROGRAM



SC DAV Organizations and DORN VA Medical Center Volunteer Services offer van rides to Veterans with medical appointments at Dorn VA Medical Center Only.

To schedule a ride, call **803-695-7949** to make an appointment.

Reservations for a van ride must be made **no later than one calendar week before your appointment.**

All medical appointments must be:

- no earlier than 9 am
- and no later than 12 noon.

There are 15 available days from which to you can choose to reserve a van ride. *\*\*Veterans must have proof of medical appointment at DORN VA.*

You may bring a caregiver with you, if there is an open seat not needed by a Veteran with an appointment.

Reservations for a van ride are on a first-come/first-serve basis. There are only 6 available seats in one round-trip.

## Rules for 2026 Rifle Raffle

- Persons under the age of 18 may not participate or receive winnings.
- All Federal and South Carolina firearm regulations must be met before you receive firearm (you must pass a background check), unless you choose to use the gift card for other items at Sportsman's Warehouse.
- Tickets are non-transferrable and non-refundable
- New Rule: To be in compliance with S.C. Code Section 33-57-140 (A), all gross proceeds must be sent to the Department for each ticket (\$25.00).
- The Department then turns around, and sends \$10.00 per ticket, back to the posts as a contribution, which the post reports on their 990's, as they do now.
- Winning tickets will be announced daily, except the Thursday, Friday, Saturday & Sunday winner will be announced the Thursday of each week.
- Winners will be notified by phone and/or email.
- Winning names and selling posts will be put on the Department website at <https://www.southcarolinalegion.org>. Each entry has an equal chance to win.
- Prizes and dates awarded are printed on the back of the rules and ticket sheet.
- Post must send checks to Department for processing. Cash will not be accepted.
- Drawing will be held at The American Legion Department of South Carolina.
